ITEM TITLE:

Resolution of the City of Coral Gables City Commission, with attachments, accepting the City Clerk’s Certification and Declaration of Results from the Coral Gables Retirement Board Election, which was held from December 11th, 2012 through December 14th, 2012; said election which confirmed the re-election of Donald “Rusty” Hill to the Participating Regular Full-Time Employee seat for a term of two years, which began on January 1, 2013 and continues through December 31, 2014; and the re-election of Troy Easley who ran unopposed for the Participating Firefighter seat for a term of two years, which also began on January 1, 2013 and continues through December 31, 2014.

RECOMMENDATION OF THE CITY CLERK:

The City Clerk recommends approval of the aforementioned Resolution.

BRIEF HISTORY

On October 25, 2012, election notices and nominating petition forms were distributed to each department within the City of Coral Gables for two participating regular full-time employees to serve on the Retirement Board as participant Retirement Board members. One candidate would be elected by the participating Firefighters and the second candidate would be elected by Regular Full-Time employees. The following individuals qualified, and their names were placed on the petition forms: Troy Easley (Fire), Donald “Rusty” Hill (Finance), and Jason Swift (Police). One incumbent representative was unopposed, namely Troy Easley who was previously serving on the Retirement Board, as Firefighter representative and has been automatically re-elected to serve as participant Retirement Board Member pending confirmation by the City Commission. The remaining candidates for the Participating Regular Full-time Employee seat were voted upon during the Election Period of December 11th through December 14th, 2012, which resulted in Donald “Rusty” Hill being elected.
