RESOLUTION NO. 2023-271

A RESOLUTION OF THE CITY COMMISSION
RETROACTIVELY APPROVING THE EXECUTION OF
AN URBAN QUALIFICATION COOPERATION
AGREEMENT BETWEEN THE CITY OF CORAL
GABLES AND MIAMI-DADE COUNTY.

WHEREAS, Miami-Dade County is undergoing requalification with the U.S. Department of Housing and Urban Development (HUD) to secure future Community Development Block Grant (CDBG) and Home Investment Partnership (HOME) funds for low- and moderate-income housing or other similar housing rehabilitation program, with the primary objective of promoting and development of viable urban communities; and

WHEREAS, the specific programs covered by the requalification are CDBG, HOME and Emergency Shelter Grants (ESG); and

WHEREAS, municipalities, based on their population status, are provided the opportunity to file directly with HUD or participate with the County for the distribution of federal funds; and

WHEREAS, the City cooperated as an Urban County Joint Entitlement recipient for fiscal years 2018-2020; and

WHEREAS, the City's continued status as a participating community will result in the City being eligible to receive future funding; and

WHEREAS, the Urban Qualification Cooperation Agreement between the City and Miami-Dade County was executed on September 19, 2023, due to the time sensitive nature of the Agreement and HUD deadlines; and

WHEREAS, this resolution retroactively authorizes the execution of that agreement, which covers the period of Fiscal Years 2024, 2025, and 2026, and is attached to this Resolution for reference;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the City Commission retroactively approves the execution of the Urban Qualification Cooperation Agreement, which covers the period of Fiscal Years 2024, 2025, and 2026, and is attached to this Resolution for reference.

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.


