UNTIL 10:00 P.M., DURING THE **"GABLES CHILI FEST"** EVENT TO BENEFIT THE KNIGHTS OF COLUMBUS AS WELL AS THE UNITED WAY MISSION; SUBJECT TO FLORIDA DEPARTMENT OF PROFESSIONAL REGULATION REQUIREMENTS.
