A RESOLUTION OF THE SCHOOL COMMUNITY RELATIONS COMMITTEE (“COMMITTEE”) REQUESTING THAT THE CITY COMMISSION MAKE A DECISION TO REFER FUTURE DEVELOPMENT PROJECTS THAT AFFECT CORAL GABLES SCHOOLS TO THE COMMITTEE, IN ORDER TO PROVIDE NOTIFICATION TO THE COMMITTEE SO THAT THE COMMITTEE CAN BRING IT UP TO PARENTS, SO THAT EVERYBODY IS AWARE OF THESE PROJECTS GOING FORWARD.

WHEREAS, on October 16, 2020, the School Community Relations Committee (“Committee”) discussed the approved WAWA project to be located at 280 South Dixie Highway; and

WHEREAS, the Committee heard from members of the public, including parents of students at G.W. Carver Middle School, the PTA President of G.W. Carver Elementary School, District 6 School Board Member Mari Tere Rojas, and City Staff; and

WHEREAS, City Attorney Opinion 2020-03 regarding the Bahamian Village Site Plan was also discussed at the Committee Meeting; and

WHEREAS, the Committee expressed a shared opinion that the City of Coral Gables should provide more targeted notice to the Miami Dade County Public School District and its discreet schools when a development is planned in the vicinity of a school; and

WHEREAS, as a result of the discussions that took place at the October 16th meeting, the Committee passed this resolution, requesting that the City Commission refer future development projects that affect Coral Gables schools to the Committee, in order to provide notification to the Committee so the Committee can in turn facilitate notification to parents of students at said schools.

NOW THEREFORE BE IT RESOLVED BY THE SCHOOL COMMUNITY RELATIONS COMMITTEE OF THE CITY OF CORAL GABLES, FLORIDA THAT:

SECTION 1. That the foregoing “WHEREAS” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the School Community Relations Committee requests that the City Commission refer future development projects that affect Coral Gables schools to the Committee, in order to provide notification to the committee so that the committee can bring it up to parents, so that everybody is aware of these projects going forward.

SECTION 3. Said Resolution shall become effective upon the date of its adoption herein.
