Chief de la Rosa further stated our National Standard is 90 minutes, our City is doing it well under 60 minutes, our goal is to not only increase survivability, but a decrease in the disability of patients having a heart attack, ultimately we want to make this the safest place for you to experience a heart attack, if you have one. Chief de la Rosa thanked everyone in attendance.
