SECRETARY'S REPORT:

Discuss Development Review Process

Ramon Trias, Development Services Assistant Director presented to the Board the development review process regarding all proposed projects that will be implemented within the City of Coral Gables. There was discussion among the Board regarding the topic.

New Driving While Texting Law

A bill that will increase the penalty for texting and driving has passed the legislature and is heading to Governor Ron DeSantis for his signature. Under Florida law it's currently a secondary offense to text and drive. But the new bill would make it a primary offense starting July 1. While the law goes into effect in July, starting on Oct. 1, law enforcement will only issue warnings. On Jan. 1, police would resume stopping drivers and issue tickets. The penalty for a first offense would be \$30, plus court costs that could more than double the initial penalty. A second offense within five years of the first one would result in a \$60 fine, plus court costs, and three points on the driver's license.
