Chairman Mr. Thad Adams brought the meeting to order at 8:12 a.m.

c) Community of Excellence

Mr. David Harrawood from Baldrige Group, LLC. who is the team's consultant, provided the Board with a presentation regarding the Community of Excellence 2026 program. Mr. Harrawood explained that the Malcom Baldrige program created a Community of Excellence Award using Baldrige criteria. The city, in partnership with the Chamber of Commerce, Community Foundation, and Doctors Hospital/Baptist Health South Florida have been working on achieving a Community of Excellence Award for several years. The first ever Community of Excellence Award is scheduled to be awarded in 2026 at the White House by the President.

There are five pillars of excellence that the city is being judged on: Quality of Life, Health & Wellness, Educational Excellence, Safe Neighborhoods, Thriving Economy. Mr. Harrawood's explained the several key indicators for each pillar and how the city compares to Miami-Dade County, Florida and the Nation. The goal is to rank at 80% or higher in each key indicator or 20% higher than the benchmark.

There was discussion regarding high school graduation and reading proficiency rates. This is an area that requires special attention for improvement.

Mr. Harrawood informed the Board that the COE Baldrige Conference will take place in October at the Biltmore Hotel and invited the Board members to attend. This is the first time the conference has been held in Florida.

Mrs. Belkys Perez updated the Board on the new and soon-to-come businesses in Coral Gables.
