Police Update

No updated provided. David asked about traffic on Ponce De Leon going south. David asked for increased surveillance on Sarto, Romano and Ponce due to speeding. Sgt Erasmo will arrange to have surveillance in those areas. Debbie advised the Sgt. Lopez that the 4-way stop on Pisano and University is being ignored. Sgt. Lopez advised that surveillance will be increased.

CHAIRMAN'S REPORT

Scooters on Sidewalks

Sgt. Lopez advised that scooters on sidewalks are not allowed. The Board clarified that scooters are prohibited in the downtown area.

Sue requested to have "Public Comment" permanently on the agenda under "Police Update".

• The Annual Report

Sue requested that all members of the board contribute to the annual report. Sue stated she would like the Board members to write a summary of what they are passionate about. Roberta stated that the annual report is based on accomplishments. Peter asked for clarification on whether Sue would draft it and send it to staff.

Secretary's Report

Staff provided updates on three traffic impact studies:

- 1. 290 Valencia Final copy has been submitted. In review by commission. Sue request Cliff notes on the project. Mairelys advised that all intersections and roadways segments are expected to operate with no major impacts. The project has been reviewed and tested, based on the data the repurposing of a traffic lane shows no major impact. Sue asked how many units in the project and who the contactor was. Mairelys advised the contractor is Calvin Giordano and 175 multifamily units and a restaurant is what's proposed. Melissa clarified that this project did not meet the criteria for a traffic impact study. The City requested a traffic impact study for what was being proposed. Sue stated that the data doesn't seem accurate for a parking lot turned into a multi-family building. Staff advised that the current facility is a dealership with auto servicing. Debbie requested to see a traffic impact study stating that attacking the staff because of results from a traffic impact study conducted by a contactor is putting staff on the line for a study they did not perform. Sue asked who was attacking staff stating that yes, staff has to sign off on the reports.
- 2. The Crystal Project The recommendation was for timing and signal adjustments and traffic circulation plan. David asked how many units. Staff advised 184 dwelling units, 16 live/work units, 60 student school, and a parking garage.
- 3. 4225 Ponce some intersections require signal retiming. Miami-Dade County is requesting a loading operation plan for the service vehicles David requested a visual.
