Planning and Zoning Director Trias: Mayor this is the Comprehensive Plan aspect of the work that Fred has been doing with Master Plan for public spaces and recreation. It establishes the level of services, and it also includes a map that has all of the new parks that have been acquired by the city and so on. It updates the requirements and in addition, I think it creates some more targeted goals. Fred, do you want to say.

Parks and Recreation Director Couceyro: Yes. It kind of covers what we covered in the Master Plan. We updated the maps; we've updated the radius. As we did in our city's strategic plan, remember we started looking at busy roadways to cut off that radius, we didn't want people having to cross a major roadway to have a park in their neighborhoods, so that's reflected in the maps; and we also included the Master Plans in the Comp Plan as well, and we did some minor changes that were long standing, like it used to be the Parks and Recreation Department now its Community Recreation, that kind of thing. We just cleaned some things up.
