**RESOLUTION NO. 2019-301**

A RESOLUTION OF THE CITY COMMISSION GRANTING THE REQUEST MADE BY MAKE-A-WISH SOUTHERN FLORIDA TO WAIVE CERTAIN PERMIT FEES ASSOCIATED WITH THE “*WINGS FOR WISHES*” EVENT, TO BENEFIT THE MAKE-A-WISH SOUTH FLORIDA. ON SATURDAY, FEBRUARY 29, 2020 BEGINNING AT 12:00 NOON UNTIL 4:30 P.M., SUBJECT TO FLORIDA DEPARTMENT OF PROFESSIONAL REGULATION REQUIREMENTS.

**WHEREAS** the Make-a-Wish foundation is a non-profit organization that grants ill-children with life-changing opportunities; and

**WHEREAS** one hundred percent (100%) of the proceeds accrued through their events go toward the children;

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**

**SECTION 1.** That the City Commission does hereby grant permission to Make-a-Wish Southern Florida, to serve alcoholic beverages during the “*Wings for Wishes*” event, and subject to the adherence of the laws of the State of Florida.


**SECTION 2.** That this event will take place at the parking lot, located on 1159 Sunset Drive and northern adjacent street (San Ignacio) on Saturday, February 29, 2020, beginning at 12 noon until 4:30 p.m. “*Wings for Wishes*” is a fun event hosted by Make-A-Wish, local professionals committed to making life better for children with life-threatening medical conditions. The event will take place behind Sports Grill South Miami and will be in a “block party” format with a wing tasting component, in addition to the crowd-favorite wing eating competition. Sports Grill will feature six different tasting stations, while patrons will be able to pair their food with a variety of different craft beers and/or wine. The afternoon will feature live music, a DJ, and plenty of fun events for children and adults alike. 100% of the proceeds benefit Make-A-Wish Southern Florida.


