**RESOLUTION NO. 2020-181**

A RESOLUTION ACCEPTING THE RECOMMENDATION OF THE CHIEF PROCUREMENT OFFICER TO APPROVE A CHANGE ORDER PURSUANT TO SECTION 2-764(B), APPROVAL OF CHANGE ORDERS AND CONTRACT MODIFICATIONS, OF THE PROCUREMENT CODE AND INCREASE THE SPENDING AUTHORITY ON THE MANAGED SERVICE PROVIDER SERVICES CONTRACT RFP 8-43 WITH GUIDESOFT, INC., DBA KNOWLEDGE SERVICES IN THE ESTIMATED AMOUNT OF \$780,674.00 NOT TO EXCEED THE AVAILABLE BUDGET.

**WHEREAS**, Guidesoft, Inc, dba Knowledge Services, has been the awarded contractor for RFP 8-43 Managed Service Provider Services contract since September 8, 2009; and

**WHEREAS**, the contract allows for the City to request temporary labor from Knowledge Service to provide ready productive employees based on hourly rates and different personnel classification; and

**WHEREAS**, the City's departments have identified a need for the services in order to maintain the operational needs of the City; and

**WHEREAS**, the Chief Procurement Officer finds that utilizing the existing contract is in the City's best interest and will allow the departments to continue providing the needed services for the City; and

**WHEREAS**, when necessary, other City departments may utilize the contracted services to meet operational goals for their respective departments;

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**

**SECTION 1.** The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**SECTION 2.** The City Commission accepts the recommendation of the Chief Procurement Officer to increase the spending authority in an estimated amount of \$780,674.00, not to exceed the available budget, through the term of the contract ending on December 31, 2021, pursuant to Section 2-764(b) of the Procurement Code entitled "Approval of Change Orders and Contract Modifications".

**SECTION 3.** This Resolution shall become effective upon the date of its adoption herein.
