## **RESOLUTION NO. 2023-281**

A RESOLUTION OF THE CITY COMMISSION AUTHORIZING AN AMENDMENT TO THE FISCAL YEAR 2022-2023 ANNUAL BUDGET REVERSE THE \$5,000,000 TO REVENUE RECOGNITION FROM THE SALE OF HISTORIC FACILITY TRANSFER OF DEVELOPMENT RIGHTS (TDRs), TO REVERSE THE APPROPRIATION OF SUCH FUNDS, AND TO RECOGNIZE AS REVENUE A \$4,000,000 TRANSFER FROM FUND BALANCE TO BE USED TO COVER THE COST OF THE HISTORIC FACILITY RENOVATIONS ORIGINALLY FUNDED BY THE TDR SALE.

**WHEREAS,** the Fiscal Year 2022-2023 adopted budget included revenue of \$5,000,000 to be generated from the sale of Transfers of Development Rights (TDRs) belonging to historic City facilities; and

**WHEREAS**, \$4,000,000 of the \$5,000,000 was appropriated to help cover the cost of much needed renovations to the Venetian Pool and the Gondola Building, and the remaining \$1,000,000 transferred to historic building fund balance for future historic City facility renovations; and

WHEREAS, negotiations for the sale of TDRs have been ongoing but to date, the revenue not realized; and

**WHEREAS**, the \$5,000,000 revenue recognition from the TDR sale as well as the related appropriation of such funds will be reversed by way of this budget amendment; and

**WHEREAS**, A \$4,000,000 transfer from Capital Improvement fund balance is required to fund the historic facility renovations formerly funded by the TDR sale; and

**WHEREAS,** an amendment to the Fiscal Year 2022-2023 annual budget is required to reverse the \$5,000,000 revenue recognition from the sale of historic facility Transfer of Development Rights (TDRs), to reverse the appropriation of such funds, and to recognize as revenue a \$4,000,000 transfer from fund balance to be used to cover the cost of the historic facility renovations originally funded by the TDR sale.

## NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

**SECTION 1.** That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon the adoption hereof.

**SECTION 2.** The City Commission does hereby authorize an amendment to the Fiscal Year 2022-2023 annual budget to reverse the \$5,000,000 revenue recognition from the sale of historic facility Transfer of Development Rights (TDRs), to reverse the appropriation of such funds, and to recognize as revenue a \$4,000,000 transfer from fund balance to be used to cover the cost of the historic facility renovations originally funded by the TDR sale.
