Dear Robert:

Thank you for taking the time to allow me an overview of your project needs. Fast-Dry Courts, Inc. proposes to provide the scope of work described as resurface eight (8) Har-Tru (Marl) tennis courts (Courts #1-8), in two 4-court batteries, each measuring 240' x 120'. Clean surface to remove visible surface algae and dead material; remove old lines and nails, scarify surface as needed, redistribute excess usable green rock from the low end to the high end, apply one hundred and sixty (160) tons of new Har-Tru material (+/- 20 tons per court) using laser guided grading equipment to help re-establish the original court slope and a more optimal surface depth. Install new herringbone style line tapes secured with 2-1/2" aluminum nails to USTA specifications. Repaint net posts (black) and reinstall existing tennis nets and center straps. Courts will be rolled to initial firmness. All wastes will be left near the court at Owner's provided dump site for the total cost of **\$139,650.00**.

Resurface five (5) Har-Tru tennis courts (Courts #9-13) in one 3-court battery measuring 180' x 120', and one 2-court battery measuring 120' x 120'. Clean surface to remove visible surface algae and dead material; remove old lines and nails, scarify surface as needed, redistribute excess usable green rock from the low end to the high end, apply fifty (50) tons of new Har-Tru material (+/- 10 tons per court) using laser guided grading equipment to help re-establish the original court slope and a more optimal surface depth. Install new herringbone style line tapes secured with 2-1/2" aluminum nails to USTA specifications. Repaint net posts (black) and reinstall existing tennis nets and center straps. Courts will be rolled to initial firmness. All wastes will be left near the court at Owner's provided dump site for the total cost of **\$54,500.00**.
