RESOLUTION NO. 2024-49

A RESOLUTION OF THE CITY COMMISSION ACCEPTING A RECOMMENDATION TO WAIVE THE COMPETITIVE PROCESS OF THE PROCUREMENT CODE AND PURCHASE THE LUCAS AND LIFEPAK15 ANNUAL MAINTENANCE SERVICE AS A SOLE SOURCE PROCUREMENT, *PURSUANT TO SECTION 2-689 OF THE CITY'S* PROCUREMENT CODE.

WHEREAS, the Fire Department purchased the LUCAS and Lifepak15 devices starting in 2010 for their Rescues; and

WHEREAS, the LUCAS and Lifepak15 devices are utilized on all cardiac and cardiac arrest incidents by the Fire Department Paramedics; and

WHEREAS, the Fire Department has the need to renew the annual maintenance service agreement for a period of one (1) year at \$28,325.40; and

WHEREAS, the City is seeking approval to purchase the on-going maintenance for the existing LUCAS and Lifepak15 devices; and

WHEREAS, Section 2-689 of the Procurement Code entitled "Sole Source Procurement" authorizes an award without competitive bids when there is only one source available to fulfill the needs of the city; and

WHEREAS, Section 2-585 of the Procurement Code, entitled "Authority" authorizes the City Manager to delegate authority to the Procurement Officer to administer and make recommendations on contract awards;

NOW. THEREFORE. BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:


SECTION 1. The foregoing "**WHEREAS**" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the City Commission accepts a recommendation to waive the competitive process and authorizes the City Manager to purchase the LUCAS and Lifepak15 devices' annual maintenance service, pursuant to Section 2-689 of the City's Procurement Code.

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.


