RESOLUTION NO. 2010-103

RESOLUTION AUTHORIZING THE EXECUTION OF AN AFFIDAVIT AS PART OF THE REQUIREMENTS TO RECEIVE REIMBURSEMENT FINES FROM THE MIAMI-DADE COUNTY PARKING FINES REIMBURSEMENT PROGRAM, FISCAL YEAR 2009-2010.

WHEREAS, Miami-Dade County is commencing the process for the Fiscal Year 2009-2010 Parking Fines Reimbursement Program; and

WHEREAS, reimbursements to municipalities are based on a percentage of revenue collected during Fiscal Year 2008-2009, that is determined by calculating the total amount paid on tickets issued in a municipality divided by the total number of tickets paid countywide. Funding estimates include a percentage of the carryover monies that were not distributed to any municipalities in the previous year; and

WHEREAS, the combination of fines collected in the previous fiscal year, and unspent funds from other municipalities, makes available an amount of \$26,204.00 for which the City of Coral Gables may apply; and

WHEREAS, the City, in accordance with the executed Interlocal Agreement with Miami-Dade County, need only submit an Affidavit to participate in the Fiscal Year 2009-2010 Parking Fines Reimbursement Program. The Affidavit states the funds reimbursed shall be used to continue to improve accessibility and equal opportunity to qualified persons who have disabilities in the municipality and to conduct disability public awareness programs. The combination of fines collected in the previous fiscal year, and unspent funds from the municipalities, makes available an amount of \$26,204.00 for which the City may apply; and

WHEREAS, the deadline for submission of the Affidavit is June 30, 2010;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF CORAL GABLES:

SECTION 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the City of Coral Gables does hereby accept the Parking Fines Reimbursement from Miami-Dade County in the amount of \$26,204.00.

SECTION 3. That the City Commission does hereby authorize the City Manager to sign the Affidavit, thereby applying for the Parking Fines Reimbursement.

SECTION 4. That the amendment to the City's Fiscal Year 200-2010 Annual Budget is hereby authorized in the amount of \$26,204.00.

SECTION 5. This Resolution shall become effective upon the date of its adoption herein.


