**RESOLUTION NO. 2025-71**

A RESOLUTION OF THE CITY COMMISSION DIRECTING THAT THE COMMUNITY CHOICE AWARD FOR THE HOLIDAY STOREFRONT WINDOW CONTEST BE NAMED FOR FERNANDO JAIME TELLO.

**WHEREAS**, for the last few years the City has held a Holiday Storefront Windows Contest; and

**WHEREAS**, last year there were awards given for most original, best use of lights, best overall, and the Community Choice award; and

**WHEREAS**, the Community Choice award is the only award voted on by the public, representing the favorite window display of the voting community; and

**WHEREAS**, the City Commission wishes to name the Community Choice award after Fernando Jaime Tello; and

**WHEREAS**, Mr. Tello was the artist and talent behind all of the beautiful window displays at Ella Bella RoZio, a family owned atelier on Miracle Mile and a consecutive five year recipient of one of the award categories of the City's Holiday Window display awards; and

**WHEREAS**, Mr. Tello passed away unexpectedly earlier this year at the age of 36, leaving behind two young sons, Ryan Nicolas and Lucas Gabriel, his sister Ella, brother Christian, mother Rocio and father Fernando; and

**WHEREAS**, the City wishes to recognize Mr. Tello for his dedication, talent, and holiday spirit by naming the Community Choice Award in his honor;

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**



**SECTION 3.** That this Resolution shall become effective upon the date of its passage and adoption herein.


