- 1. The contract term will be extended for one (1) additional year from November 17, 2020 to November 18, 2021.
- Except as otherwise provided herein, all terms and conditions of the Professional Services Agreement, and those modifications approved by both parties in this to the Professional Services Agreement shall remain in full force and effect.
