RESOLUTION NO. 2010-187

RESOLUTION ACCEPTING THE RECOMMENDATION OF THE CHIEF PROCUREMENT OFFICER TO AWARD A CONTRACT FOR CONSTRUCTION OF STREET IMPROVEMENTS TO METRO EXPRESS PAVING COMPANY PURSUANT TO UNIT PRICING BID UNDER INVITATION FOR BID (IFB) 2010.07.15, AND SECTION 2-828 OF THE PROCUREMENT CODE FOR A PERIOD RUNNING UNTIL SEPTEMBER 30, 2011 WITH AN OPTION TO RENEW FOR TWO (2) ADDITIONAL YEARS.

WHEREAS, on June 10, 2010, the Procurement Division of Finance formally advertised the Construction of Street Improvements Invitation for Bid (IFB) 2010.07.15; and

WHEREAS, on June 17, 2010, a non-mandatory pre-bid conference was held with four (4) prospective bidders in attendance of the thirty-five (35) contractors and subcontractors who downloaded the bid document from the Procurement website or picked up the bid package from the Procurement Division of Finance; and

WHEREAS, on July 15, 2010, ten (10) bids were submitted by: Rock Power Paving, Maggolo Inc., Wrangler Construction, Inc., Horizon Contractors, Williams Paving Company, Inc., JVA Engineering Contractor Inc., Florida Engineering and Development, Gonzalez Pavement, H & R Paving and Metro Express Paving Company; and

WHEREAS, the lowest responsive responsible bidder for this contract was determined to be Metro Express Paving Company, Inc. under 2-766 (g), entitled "***Correction or withdrawal of bids; cancellation of Awards***", of the Procurement Code pursuant to unit pricing bid under Invitation For Bid (IFB) 2010.07.15; and

WHEREAS, Section 2-650, entitled "***Authority***" of the Procurement Code authorizes the City Manager to delegate authority to the Chief Procurement Officer to administer and make recommendations on City contracts;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the City Commission does hereby accept the recommendation of the Chief Procurement Officer to award a contract for Construction of Street Improvements to Metro Express, Inc. pursuant to unit pricing bid under Invitation For Bid (IFB) 2010.07.15 and Section 2-828, entitled "***Contract Award***", of the Procurement Code for a period running until September 30, 2011 with an option to renew for two (2) additional years.

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.


