RESOLUTION NO. 2020-272

A RESOLUTION OF THE CITY COMMISSION AMENDING ORDINANCE NO. 2015-17, AS AMENDED, TO ADJUST THE CITY CLERK'S FEES TO REFLECT UPDATED PRICING; PROVIDING FOR A SEVERABILITY CLAUSE AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Ordinance No. 2015-17 passed and adopted by the City Commission on June 16, 2015 and subsequently amended by Resolution No. 2016-75 on March 15, 2016, Resolution No. 2016-148 on June 14, 2016, Resolution No. 2017-167 on July 11, 2017, and Resolution No. 2018-219 on August 28, 2018 as permitted by the Ordinance, established fees for various licenses, permits, services and penalties by the City of Coral Gables; and

WHEREAS, the City Commission determined that pricing must be updated to the current pricing system; and

WHEREAS, the recommended increase contained herein is the fees associated by the State Department and cost by Department; and

WHEREAS, the goal of the fee is to create an accurate pricing system;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.




