RESOLUTION NO. 2021-332

A RESOLUTION OF THE CITY COMMISSION ALLOCATING THE ART IN PUBLIC PLACES FUNDS COLLECTED FROM THE MINORCA PARKING GARAGE PROJECT, THE FINK STUDIO PROJECT, THE RENOVATION OF 427 BILTMORE WAY AND THE CONSTRUCTION OF FIREHOUSE 4 INTO A SINGLE ACCOUNT FOR USE ON A FUTURE ART INSTALLATION.

WHEREAS, the construction of the Minorca Parking Garage and Coral Gables Fire Station 4, and the renovation of the Fink Studio and 427 Biltmore way (collectively the “Projects”), meet the requirement of a municipal construction project governed by the Miami-Dade County Code of Ordinances; and

WHEREAS, the City of Coral Gables provides for the acquisition and maintenance of art in public places consistent with Section 2-11.15 of the Miami-Dade County Code of Ordinances entitled “Works of Art in Public Places”; and

WHEREAS, the City Commission believes it is in the best interest of the City and all its residents to pool all of the funds collected for Art in Public Places from the Projects be allocated into a single account for future use in the acquisition of a larger and more significant art installation within the City;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES AS FOLLOWS:


SECTION 1. That the foregoing “Whereas” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon the adoption hereof.

SECTION 2. The City Commission does hereby direct City staff to allocate all Art in Public Places funds collected from the Projects into a single account for future use in the acquisition of a larger and more significant art installation within the City.

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.
