

The City is purchasing a replacement air truck to refill the breathing air cylinders for the firefighters.

We are requesting you purchase the truck in the above referenced purchase requisition.

This Truck is a demo vehicle; it is a 2008 Isuzu NQR truck gone 3000 miles outfitted with a custom made ambulance body. We are purchasing this truck from Custom Truck & Body Works, Inc., in Woodbury, GA. The price of this vehicle is normally \$94,995.00, the chassis & cab \$44,852.00, the body complete and installed with lighting etc. is \$50,143.00. However, because this vehicle has been used as a demonstrator and has gone just under 3000 miles we have negotiated a price of \$80,000.00.

We consider this price to be an excellent one as purchasing a new chassis & cab with similar specs on The State & Sheriffs contract and having a body similarly outfitted and installed would cost us over \$100,000.00.






