**RESOLUTION NO. 2026-123**

A RESOLUTION OF THE CITY COMMISSION ACCEPTING THE RECOMMENDATION OF THE CHIEF PROCUREMENT OFFICER TO EXTEND CONTRACT NO. RFP 2018-009A WITH ASHBRIIT, INC, RFP 2018-009B WITH PHILLIPS HEAVY, INC. AND RFP 2018-009C WITH CERES ENVIRONMENTAL SERVICES, INC. FOR DISASTER DEBRIS REMOVAL SERVICES, PURSUANT TO SECTION 2-764 OF THE CITY'S PROCUREMENT CODE ENTITLED "APPROVAL OF CHANGE ORDERS AND CONTRACT MODIFICATIONS".

**WHEREAS**, the City and Ashbriit, Inc. primary awarded vendor, previously entered into a Professional Services Agreement effective August 21 2018, ("Agreement"), for Disaster Debris Removal Services RFP 2018-009A ("Services"), Phillips and Jordan, Inc., secondary awarded vendor, previously entered into a Professional Services Agreement effective August 21 2018, ("Agreement"), for Disaster Debris Removal Services RFP 2018-009B ("Services"), and Ceres Environmental Services, Inc., tertiary awarded vendor, previously entered into a Professional Services Agreement effective December 5, 2018, ("Agreement"), for Disaster Debris Removal Services RFP 2018-009C ("Services") ; and

**WHEREAS**, The City previously approved two (2) separate extensions (Resolution 2025-98 and Resolution 2025-436) to extend the agreement until June 1, 2026, in anticipation of awarding new contracts for the services: and

**WHEREAS**, a solicitation is currently underway, and it is anticipated that the awards will be made sometime in June or thereafter; and

**WHEREAS**, the Parties desire to extend the Agreements on a month-to-month basis through July 1, 2026, and until a new contract is awarded; and

**WHEREAS**, contract changes are allowable by FEMA as long as documented procurement policies and procedures are followed pursuant to 2 C.F.R § 200.317; and

**WHEREAS**, Section 2-585 of the Procurement Code, entitled "Authority" authorizes the City Manager to delegate authority to the Chief Procurement Officer to administer and make recommendations on change orders and contract modifications; and

**NOW THEREFORE BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**


**SECTION 1.** That the foregoing “WHEREAS” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**SECTION 2.** That the City Commission accepts the recommendation of the Chief Procurement Officer and authorizes the City Manager to extend contract RFP 2018-009A, RFP 2018-009B, and RFP 2018-009C for Disaster Debris Removal Services on a month-to-month basis until a new contract is awarded, pursuant to section 2-764 of the procurement code entitled “Approval of Change Orders and Contract Modifications”.

**SECTION 3.** That this Resolution shall become effective upon the date of its passage and adoption herein.


