# D.-1. CORAL GABLES CENTENNIAL – COMMEMORATIVE ARTWORK PROPOSAL REVIEW

Staff reviewed the goals of the project and project description with board members. Board members reviewed each artist proposal and discussed thoroughly. The artists reviewed were Yanira Collado, Morel Doucet, Chris Friday, Charles Humes, Jr., William Osorio, Chire Regans, Onajide Shabaka, and Tavares Strachan.

The Board was advised of the Arts Advisory Panel recommendation to invite artists Morel Doucet, William Osorio and Tavares Strachan to the next phase.

Mr. Prime, representing the Lola B. Walker Homeowners Association, stated that three of the proposals capture the community's overall sense of what they would like to see the project represent, those of: Yanira Collado, Morel Doucet and Charles Humes Jr., and further mentioned the importance of including family names from the community.

A motion was made by Mr. Valdes-Fauli to recommend the proposal of Morel Doucet. The motion did not receive a second and failed.

The Board continued discussion, noting the benefit of requesting proposal revisions from more than one artist. Overall, members felt it was important to respond to both the Arts Panel and Community input. With no further discussion, the following motion was made:

A motion was made by Ms. Burgos, and seconded by Mr. Rodriguez, to request a proposal revision, including the incorporation of neighborhood family names, from artists Yanira Collado, Morel Doucet, and Tavares Strachan. The motion passed unanimously.

A motion was made by Mr. Fliss and seconded by Ms. Burgos to request staff review and administrative approval of change requests, providing the Board with reglar updates. The motion passed unanimously.
