**AMENDMENT # 1**

**RECITALS**

**WHEREAS**, the City and Professional entered into a Professional Services Agreement (the "Agreement") effective February 12, 2025, for interior design services (the "Project"); and

**WHEREAS**, it is necessary to add the Lecture Hall at Fink Studio to the project with an additional scope of work and funding, and amended agreement terms through September 30, 2027 or until the completion of the project; and,

**WHEREAS**, per Section 21(a) Modification, the agreement may not be amended or modified unless in writing and signed by both parties.

**NOW, THEREFORE**, the Parties agree, understand, accept, and acknowledge that through this Amendment, the Professional Services Agreement for interior design services is hereby modified as follows:

1. Extend the expiration of the project until September 30, 2027 or until the completion of the project.
2. Exhibit 4 is added to the Agreement with the scope of work to include two additional years of interior design services and applicable payment.
3. All other terms of the conditions remain unchanged and in effect.
