RESOLUTION NO. 2026-29

A RESOLUTION OF THE CITY COMMISSION ACCEPTING THE RECOMMENDATION OF THE CHIEF PROCUREMENT OFFICER TO AUTHORIZE THE USE OF A COOPERATIVE CONTRACT WITH GENUINE PARTS COMPANY D/B/A NAPA AUTO PARTS FROM HILLSBOROUGH COUNTY SHERIFF'S OFFICE (HCSO) CONTRACT NUMBER FSA-HCB-IB1.0 TO PROVIDE ON-SITE VEHICLE AND EQUIPMENT PARTS AND SUPPLY SERVICES IN AN AMOUNT NOT TO EXCEED BUDGETED FUNDS PURSUANT TO SECTION 2-947 OF THE PROCUREMENT CODE ENTITLED "COOPERATIVE PURCHASING".

WHEREAS, the City's on-site vehicle and equipment parts and supply services are provided by Genuine Parts Company dba NAPA Auto Parts; and

WHEREAS, Procurement is recommending utilizing the cooperative agreement through the Hillsborough County Sheriff's Office (HCSO) under Section 2-947 of the Procurement Code; and

WHEREAS, the current HCSO contract with NAPA Auto Parts was competitively solicited under RFP No. 2024-017 which complies with the solicitation requirements contained within Section 2-945 of the Procurement Code; and

WHEREAS, the Chief Procurement Officer recommends the utilization of this contract awarded by HCSO with Genuine Parts Company dba NAPA Auto Parts; and

WHEREAS, under Section 2-947, the City may participate in cooperative purchasing agreements for the procurement of any goods or services with one or more governmental units in accordance with an agreement entered into between the participants;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the City Commission accepts the recommendation of the Chief Procurement Officer to authorize a Cooperative contract with Genuine Parts Company dba NAPA Auto Parts from the Hillsborough County Sheriff’s Office (HCSO) to provide on-site vehicle and equipment parts and supply services pursuant to Section 2-947 entitled “Cooperative Purchasing” in an amount not to exceed the available budget.

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.




