#### **B. NEW BUSINESS**

**B.-1.     [25-9256](#)     CDB Board-as-a-Whole Appointee 2025**

Board members discussed applications and nominations for the Board-as-a-Whole position. Mr. Rodriguez nominated Mr. Corral, who did not accept the nomination. Members continued discussion and considered Mr. Armando Hassun. Chair Pantin stated that he met with Mr. Hassun and discussed the role and work of the Board. He shared that he was impressed and supported him as a nominee. Following further discussion, the Board voted in favor of recommending Mr. Hassun as the Board-as-a-Whole member for the 2025-2027 term.

**A motion was made by Mr. Rodriguez and seconded by Mr. Perez to appoint Armando Hassun as the Cultural Development Board-as-a-Whole member. The motion passed unanimously.**

Board members were provided with a memo from Mayor Lago to the Commission regarding the possible acquisition of a sculpture by the artist Agustin Cardenas. They were advised that a motion was made and passed at the City Commission meeting to pursue the proposal. The Cultural Development Board discussed and agreed that it should go through the approval process and be sent to the Arts Advisory Panel. They further agreed that it should be appraised, following the practice established for existing artworks. With no further discussion, a motion was made to have the piece appraised and go to the Arts Advisory Panel for a recommendation.

**A motion was made by Mr. Rodriguez and seconded by Ms. Perez to have the Agustin Cardenas sculpture appraised and the proposal reviewed by the Arts Advisory Panel for a recommendation. The motion passed unanimously.**

Staff made a presentation regarding signage options for the public art collection. Ms. Cathers reported that the previous design was presenting challenges regarding clarity and sustainability for future projects. The presentation featured a standard design similar to other bronze signage throughout the city. She recommended keeping elements simple and using a QR code to access detailed information. A design of the proposed sign was included: bronze with a gold border using standard sign elements for artwork including artist name, artwork title, year, material, donor or partner acknowledgement if applicable, citing the Coral Gables Art in Public Places program, a note to not climb the art, and QR code. It was mentioned that braille is recommended to reference the QR code. Board members agreed with the design recommendation and with no further discussion made a motion of approval.

**A motion was made by Ms. Perez and seconded by Mr. Rodriguez to approve the public art signage design as presented. The motion passed unanimously.**

Mr. Doucet provided an update on the design of "Secrets that the Wind Carries Away." He presented a PowerPoint and discussed his involvement with the Lola B. Walker Homeowner's Association, which he recently presented to. The Board was pleased with the progress and agreed with the Arts Advisory Panel's comments to use an engraved process for the names on the side of the vessel. Members also liked the idea of the concrete being formed to emulate water.

Board members were advised of the items that will move forward to the City Commission, including approval of the newly appointed Board-as-a-Whole member, the Cultural Grants funding allocation for FY2025-2026, and the Art Week / Art Basel initiative titled "Intervals."
