**RESOLUTION NO. 2017-40**

A RESOLUTION GRANTING PERMISSION TO MAKE-A-WISH SOUTHERN FLORIDA TO SELL ALCOHOLIC BEVERAGES AT THE PARKING LOT LOCATED ON 1159 SUNSET DRIVE ON SATURDAY, MARCH 11, 2017, FROM 12:00 P.M. TO 4:00 P.M., DURING THE "**WINGS FOR WISHES**" EVENT TO BENEFIT THE MAKE A WISH SOUTH FLORIDA, SUBJECT TO FLORIDA DEPARTMENT OF PROFESSIONAL REGULATION REQUIREMENTS.

**BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**

**SECTION 1.** That the City Commission does hereby grant permission to Make a Wish South Florida to serve alcoholic beverages during the "**Wings for Wishes**" event and is in compliance with the laws of the State of Florida.

**SECTION 2.** That the event will take place at the parking lot located on 1159 Sunset Drive on Saturday, March 11, 2017, from 12:00 p.m. to 4:00 p.m. "**Wings For Wishes**" is a fun event hosted by Make-A-Wish Southern Florida by local professionals committed to making life better for children with life-threatening medical conditions. In its first two years, the event raised more than \$50,000 to grant wishes. The 2017 event will be larger and more vibrant than before. The event will take place behind Sports Grill South Miami and will be in a 'block party' format with a wing tasting component in addition to the crowd-favorite wing eating competition. Sports Grill will feature six different tasting stations, while patrons will be able to pair their food with a variety of different craft beers and/or wine. The afternoon will feature live music, a DJ, and plenty of fun events for children and adults alike. One hundred percent (100%) of the proceeds benefit Make-A-Wish Southern Florida.


**SECTION 3.** This request has been reviewed by the City's Special Events Committee.
