RESOLUTION NO. 2026-179

A RESOLUTION OF THE CITY COMMISSION AUTHORIZING THE ACCEPTANCE OF FINANCIAL PROJECT NO. 457306-1-38-01 AGREEMENT WITH THE FLORIDA DEPARTMENT OF TRANSPORTATION IN THE AMOUNT OF \$109,611 FOR THE DESIGN OF THE GRANADA BLVD SIDEWALK IMPROVEMENT PROJECT FROM DE SOTO BOULEVARD TO BIRD ROAD; AND AUTHORIZING THE CITY MANAGER TO EXECUTE SAID FINANCIAL PROJECT AGREEMENT.

WHEREAS, the City of Coral Gables (the City) was awarded a competitive grant from the Florida Department of Transportation (FDOT) in the amount of \$ 109,611.00; and

WHEREAS, the funding will be used for engineering design services along Granada Boulevard from De Soto Boulevard to SR 976/ Bird Road/SW 40 Street to provide pedestrian infrastructure on both sides of this corridor; and

WHEREAS, this safety project is critical as it would provide safe pedestrian connectivity along a collector roadway from Bird Road to nearby locations such as the Biltmore Hotel and the Venetian Pool furthering the City's goal of enhancing the pedestrian experience; and

WHEREAS, the Granada Boulevard from De Soto Boulevard to Bird Road Sidewalk Project will be included in the Fiscal Year 2026-2027 Budget for appropriation of funds; and

WHEREAS, the City Commission authorizes the City Manager and/or designee to execute the agreement for financial project no. 457306-1-38-01 and any modification or amendments to said agreement;

NOW, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES, FLORIDA:

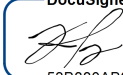

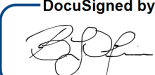
SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.

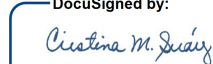
