City of Coral Gables CITY COMMISSION MEETING October 12, 2010

ITEM TITLE:

Ordinance on First Reading. Change of Land Use. An Ordinance of the City Commission of Coral Gables, Florida amending the Future Land Use Map of the Coral Gables Comprehensive Plan pursuant to small scale amendment procedures subject to ss. 163.3187, Florida Statutes, from "Commercial Use, Mid-Rise Intensity" to "Commercial Use, High-Rise Intensity" for a 1.2 acre parcel legally described as Lots 1-9 and 37-46, Block 10, Crafts Section (272 Valencia Avenue), Coral Gables, Florida; and providing for severability, repealer, codification and an effective date.

DEPARTMENT HEAD RECOMMENDATION:

The Planning Department recommends approval of the amendment to the Future Land Use Map of the Coral Gables Comprehensive Plan as referenced herein.

PLANNING AND ZONING BOARD RECOMMENDATION:

The Planning and Zoning Board acting as the Local Planning Agency at their 09.15.10 meeting recommended unanimous approval (vote: 6-0) of the application.

BRIEF HISTORY:

The proposed change of land use map designation from "Commercial Use, Mid-Rise Intensity" to "Commercial Use, High-Rise Intensity". No change in zoning is proposed from the current "C - Commercial" zoning designation. Future development of the property would undergo public hearing review (i.e. site plan review, etc) before the Planning and Zoning Board and City Commission with the submittal of request for the vacation of the public alleyway that currently bisects the site.
