**RESOLUTION NO. 2023-28**

A RESOLUTION OF THE CITY COMMISSION AUTHORIZING SERVICORP, LLC TO SELL ALCOHOLIC BEVERAGES ON ALHAMBRA CIRCLE FROM PONCE DE LEON BOULEVARD TO LE JEUNE ROAD ON SATURDAY, APRIL 29, 2023, BEGINNING AT 12:00 P.M. UNTIL 8:00 P.M. AND SUNDAY, APRIL 30, 2023, BEGINNING AT 12:00 P.M. UNTIL 7:00 P.M., DURING THE ***“SUPERCARS IN THE GABLES”*** EVENT. SUBJECT TO STATE REQUIREMENTS, INCLUDING FLORIDA DEPARTMENT OF PROFESSIONAL REGULATION REQUIREMENTS.

**WHEREAS**, pursuant to Resolution No. 2022-264, the City Commission previously authorized Servicorp, LLC to sell alcoholic beverages during its ***“SUPERCARS IN THE GABLES”*** event, originally scheduled for February 4-5, 2023; and

**WHEREAS**, Servicorp, LLC has rescheduled the event for April 29 through April 30, 2023 and has requested permission to sell alcoholic beverages during the rescheduled event;

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**

**SECTION 1.** The foregoing ***“WHEREAS”*** clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.


**SECTION 2.** That ServiCorp, LLC is authorized to sell alcoholic beverages on Alhambra Circle from Ponce de Leon to Le Jeune Road on Saturday, April 29, 2023, beginning at 12:00 p.m. until 8:00 p.m. and Sunday, April 30, 2023, beginning at 12:00 p.m. until 7:00 p.m., during the ***“SUPERCARS IN THE GABLES”*** event, subject to state requirements, including Florida Department of Professional Regulation Requirements.

**SECTION 3.** That this Resolution shall become effective upon the date of its passage and adoption herein.
