RESOLUTION NO. 2016-262

A RESOLUTION WITH ATTACHMENTS, OFFICIALLY ACCEPTING THE CITY CLERK'S CERTIFICATION AND DECLARATION OF THE RESULT OF THE CITY OF CORAL GABLES SPECIAL ELECTION, WHICH WAS HELD ON NOVEMBER 8, 2016, WHEREIN VOTERS APPROVED AN AMENDMENT TO THE CITY CHARTER RELATED TO RUN-OFF ELECTIONS IN CITY COMMISSION AND MAYORAL RACES.

WHEREAS, on November 8, 2016, following the closure of the polls at 7 p.m., in connection with the City of Coral Gables Special Election, held in conjunction with the General Election, the Miami-Dade Elections Department counted the votes cast on the ballot question providing for a City Charter Amendment related to run-off elections in City Commission and Mayoral races.

WHEREAS, the tabulation of vote count of the total ballots cast yielded the following results:


NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES, FLORIDA:


