Mayor Lago: Can we have items E-5 and E-8 next please.

City Attorney Suarez: E-5 is an Ordinance of the City Commission amending Ordinance No. 2022-14 which approved a Planned Area Development for the property legally described as Lots 1-12 and Lots 35-46, including the public, there might be a typo here, but alleyway lying in between, Block 10 and Lots 5 through 27. I don't think this is the legal description Mayor, so I'm going to probably have to revise it, but it is essentially the addresses that are 340, 330, 322, 314, 310, 300 Catalonia Avenue, 301, 309, 317, 323, 325, 333, 341 Malaga Avenue, Coral Gables, Florida to allow for certain work to be completed after the issuance of a temporary Certificate of Occupancy subject to the terms of a performance bond.

Mayor Lago: I think we can correct that between first and second reading, correct.

City Attorney Suarez: Yes. Yes, I can do that. And E-8 would be considered at the next meeting if this one's approved today.

Mayor Lago: Okay. Sir.

Mr. Navarro: Mayor, Commissioners, this item is simply to allow us to post a bond to complete some of the pending outside improvements. They are substantially complete, but we've had a couple of issues with the utility companies. We expect to have this work done quickly, but we're going to be TCO-ing in the next couple of weeks, so this item allows us to post the bond.

Mayor Lago: Pretty self-explanatory – quick question.

Mr. Navarro: Yes.

Mayor Lago: We'll get a motion and a second on that. Can I get a motion and a second.

Vice Mayor Anderson: I'll move it.

Commissioner Castro: I'll second.

Mayor Lago: Mr. Clerk, do we have any public comment?

Mayor Lago: Alright. Before we move on, have we addressed the issue that's pending with the park, the conversations we were having with the Manager, and we've had multiple meetings.
