**RESOLUTION NO. 2010-250**

RESOLUTION ACCEPTING AND AUTHORIZING THE EXECUTION OF A GRANT AWARD IN THE AMOUNT OF \$8,461.00 FROM THE FISCAL YEAR 2011 DRUG CONTROL AND SYSTEM IMPROVEMENT GRANT PROGRAM AWARD TO FUND THE CORAL GABLES RECORD IMPROVEMENT PROJECT TO PURCHASE A RECORDS KIOSK, PRINTERS, AND DIGITAL CAMERAS.

**WHEREAS**, the Coral Gables Police Department is the established local law enforcement agency for the provision of law enforcement services within the jurisdictional boundaries of the City of Coral Gables; and

**WHEREAS**, the State of Florida Department of Law Enforcement, through the Miami-Dade Office of Criminal Justice Grants, has awarded funding to the Coral Gables Police Department; and

**WHEREAS**, the Coral Gables Police Department has identified the need to purchase a records kiosk to assist the public with obtaining police reports, purchase printers for the holding cell, and to purchase digital cameras for the officers in the Uniform Patrol Division; and

**WHEREAS**, this Resolution will support the acceptance of the Fiscal Year 2011 Drug Control and System Improvement Grant Program Award by the local governing body;

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**

**SECTION 1.** The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**SECTION 2.** That the City Commission does hereby approve and support the Coral Gables Police Department in their acceptance of the State of Florida Department of Law Enforcement Fiscal Year 2011 award, to fund the Coral Gables Record Improvement Project to purchase a records kiosk, printers, and digital cameras in the amount of \$8,461.00.

**SECTION 3.** That this resolution shall become effective upon the date of its passage and adoption herein.


