**RESOLUTION NO. 2026-**

A RESOLUTION WITH ATTACHMENTS, OFFICIALLY ACCEPTING THE CITY CLERK’S CERTIFICATION AND DECLARATION OF THE RESULT OF THE CITY OF CORAL GABLES SPECIAL REFERENDUM ELECTION, WHICH WAS HELD ON APRIL 21, 2026, WHEREIN VOTERS APPROVED OF **REFERENDUM 6- REQUIRING A VOTE OF THE ELECTORS PRIOR TO CHANGING THE COMPENSATION OF CITY ELECTED OFFICIALS.**

**WHEREAS**, on April 21, 2026, following the closure of the polls at 7 p.m., in connection with the City of Coral Gables Special Referendum Election, the Miami-Dade Elections Department counted the votes cast on the ballot question providing for a City Charter Amendment related to requiring a vote of the electors prior to changing the compensation of City elected officials.

**WHEREAS**, the tabulation of vote count of the total ballots cast yielded the following results:

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES, FLORIDA:**

**SECTION 1.** The City Commission does hereby accept the City Clerk’s Certification and Declaration of the Result of the April 21, 2026 Special Election wherein the ballot question, **Referendum 6- providing for City Charter Amendment related to requiring a vote of the electors prior to changing the compensation of City elected officials was approved, attached hereto and made a part of this Resolution.**

**SECTION 2.** That this Resolution shall become effective upon the date of its passage and adoption herein.
