RESOLUTION NO. 2026-187

A RESOLUTION OF THE CITY COMMISSION DIRECTING THE CITY MANAGER AND CITY ATTORNEY TO DRAFT PROPOSED LEGISLATION TO EXPAND THE PARKS AND RECREATION YOUTH ADVISORY BOARD INTO THE CORAL GABLES TEEN ADVISORY BOARD BY EXPANDING ITS SCOPE INTO A BROADER CITYWIDE ADVISORY BOARD; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City’s Parks and Recreation Youth Advisory Board primarily functions to improve the quality of life and recreational needs of the youth of the City; and

WHEREAS, the proposed Coral Gables Teen Advisory Board will focus on broader cross-departmental Citywide needs and impacts of the youth of the City; and

WHEREAS, on July 7, 2026, the City Commission directed City Manager and City Attorney to draft proposed legislation to expand the Parks and Recreation Youth Advisory Board into the Coral Gables Teen Advisory Board, which will create a broader Citywide advisory board that will provide input and recommendations on matters affecting the youth in the City across all City departments, programs, initiatives, and services;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing “**WHEREAS**” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. The City Commission directs the City Manager and City Attorney to draft proposed legislation to expand the Parks and Recreation Youth Advisory Board into the Coral Gables Teen Advisory Board by expanding its scope into a broader Citywide advisory board.

SECTION 3. This Resolution shall become effective upon the date of its passage and adoption herein.

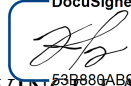

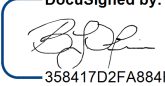

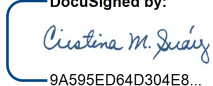
