A RESOLUTION OF THE CITY COMMISSION ACCEPTING THE RECOMMENDATION OF THE CITY MANAGER TO PURCHASE THE PRIORITY DISPATCH TECHNOLOGY PRODUCTS, SERVICES, SOLUTIONS & RELATED PRODUCTS & SERVICES, PURSUANT TO SECTION 2-689, SOLE SOURCE PROCUREMENT OF THE PROCUREMENT CODE OF THE CITY'S PROCUREMENT CODE IN THE AMOUNT OF \$25,200.00.

WHEREAS, the City Public Safety operations have been using the Priority Dispatch ProQA since 2007 in support of Fire and Police Medical emergency calls for service; and

WHEREAS, the Priority Dispatch ProQA is used by Emergency Operations call takers during 911 calls to ascertain the nature and details of an emergency via a question-and-answer protocol provided by the ProQA software; and

WHEREAS, there is an ongoing need to continually provide access to Priority Dispatch ProQA critical operational Medical support products and services through the current year; and

WHEREAS, the Procurement Officer has determined that Priority Dispatch is the sole source provider of Medical support products and services under Section 2-689 of the Procurement Code; and

WHEREAS, Section 2-650 of the Procurement Code, entitled "Authority" authorizes the City Manager to delegate authority to the Chief Procurement Officer to administer and make recommendations on City contracts;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.
