RESOLUTION NO. 2009-177

A RESOLUTION OF SUPPORT FOR THE POLICE DEPARTMENT'S APPLICATION TO THE FISCAL YEAR 2009 LOCAL EDWARD BYRNE MEMORIAL JUSTICE ASSISTANCE GRANT (JAG) PROGRAM FOR \$13,767.00 TO FUND THE PURCHASE OF PORTABLE GRAFFITI CAMERAS.

WHEREAS, the Coral Gables Police Department is the established local law enforcement agency for the provision of law enforcement services within the jurisdictional boundaries of the City of Coral Gables; and

WHEREAS, the U. S. Department of Justice Office of Justice Programs, Bureau of Justice Assistance, has grant funding programs that state and local law enforcement agencies can submit applications to; and

WHEREAS, the Coral Gables Police Department as the recognized local law enforcement agency is eligible to apply to the U. S. Department of Justice Office of Justice Programs, Bureau of Justice Assistance, for the Fiscal Year 2009 Local Edward Byrne Memorial JAG Grant; and

WHEREAS, The Coral Gables Police Department has identified the need to deter, investigate, and arrest individuals that graffiti property within the City through the purchase of portable graffiti cameras; and

WHEREAS, this Resolution will satisfy the Department of Justice requirement that the local governing body has been noticed that a local law enforcement agency has applied for grant funding for a program in their jurisdiction;

NOW THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the City Commission does hereby approve the Coral Gables Police Department application to the Department of Justice Office of Justice Programs, Bureau of Justice Assistance, for thirteen thousand seven hundred and sixty-seven dollars (\$13,767.00), to fund the purchase of portable graffiti cameras.

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.
