RESOLUTION NO. 2024-98

A RESOLUTION OF THE CITY COMMISSION APPROVING AN AMENDMENT TO THE INTERGOVERMENTAL AGENCY AGREEMENT WITH MIAMI-DADE COUNTY TO PERFORM TRAFFIC ENGINEERING FUNCTIONS.

- **WHEREAS,** in September of 2018 the City of Coral Gables and Miami-Dade County executed an Intergovernmental Agency Agreement for the performance of traffic calming engineering functions; and
- WHEREAS, pursuant to the Intergovernmental Agency Agreement the City has taken on additional responsibilities over certain traffic engineering functions pertaining to its local municipal streets; and
- **WHEREAS,** pursuant to section 13 of the Intergovernmental Agency Agreement the City and County wish to amend the agreement to add an additional traffic control device to Section 2 of the Intergovernmental Agency Agreement; and
- **WHEREAS,** the City wishes to add "modified speed humps", as detailed in the approved County design, attached here, as a traffic control device that the City may install and maintain subject to the requirements of the Intergovernmental Agency Agreement; and
- **WHEREAS**, the modified speed hump is a shortened speed table for use when a standard speed table cannot be used because of existing site conditions; and
- WHEREAS, all other provisions of the Intergovernmental Agency Agreement remain in effect including the traffic calming criteria and standard designs for the previously approved traffic control devices; and
- **WHEREAS**, the City Commission wishes to authorize the City Manager and City Attorney to execute an amendment to the Intergovernmental Agency Agreement, in substantially similar format;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the City Commission authorizes the City Manager and City Attorney to execute an Amendment to the Intergovernmental Agency Agreement to Perform Traffic Engineering Functions, executed on September 26, 2018, in substantially similar format to that attached to this Resolution.

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.

AMENDMENT TO INTERGOVERNMENTAL AGENCY AGREEMENT TO PERFORM TRAFFIC ENGINEERING FUNCTIONS

THIS AMENDMENT ("Amendment") is made and entered into this ___ day of _____, 2024, by and between the CITY OF CORAL GABLES (the "City") a municipal corporation of the State of Florida, and MIAMI-DADE COUNTY (the "County"), a political subdivision of the State of Florida.

WHEREAS, the City and the County executed an Intergovernmental Agency Agreement ("Intergovernmental Agreement") for the performance of traffic calming engineering functions on September 26, 2018; and

WHEREAS, pursuant to the Intergovernmental Agreement the City has taken on additional responsibilities over certain traffic engineering functions pertaining to its local municipal streets;

WHEREAS, pursuant to section 13 of the Intergovernmental Agreement the City and County wish to amend the Intergovernmental Agreement to add an additional traffic control device to Section 2 of the Intergovernmental Agreement; and

WHEREAS, the City wishes to add "modified speed humps", as detailed in the approved County design, incorporated into "Exhibit C" as amended, as a traffic control device that the City may install and maintain subject to the requirements of the Intergovernmental Agreement; and

WHEREAS, all other provisions of the Intergovernmental Agreement remain in effect including the traffic calming criteria and standard designs for the previously approved traffic control devices.

- **NOW, THEREFORE,** the Parties agree, understand, accept, and acknowledge that through this Amendment, the Intergovernmental Agency Agreement is amended as follows:
- **SECTION 1.** Pursuant to Section 13 of the Intergovernmental Agreement, Modified Speed Humps shall be added as an approved Traffic Control Device in Section 2. "Traffic Control Devices" of the Intergovernmental Agreement.
- **SECTION 2.** "Exhibit C" of the Intergovernmental Agreement is amended to incorporate the attached modified speed hump design entitled " ZONE 1 Traffic Calming Improvements Speed Hump".
- **SECTION 3**. All other terms, conditions, and provision of the Intergovernmental Agreement remain unchanged and in effect.
