RESOLUTION NO. 2021-252

A RESOLUTION OF THE CITY COMMISSION ACCEPTING THE RECOMMENDATION OF THE CHIEF PROCUREMENT OFFICER TO EXTEND THE CURRENT CITYWIDE RIGHT- OF-WAY IMPROVEMENTS CONTRACT WITH METRO EXPRESS, INC., PURSUANT TO SECTION 2-829 OF THE PROCUREMENT CODE ENTITLED “APPROVAL OF CHANGE ORDERS AND CONTRACT MODIFICATIONS,” AND ALLOW FOR A SIX (6) MONTH EXTENSION UNTIL MAY 3, 2022, FOR THE COMPLETION OF ON-GOING RIGHT OF WAY PROJECTS.

WHEREAS, on August 29, 2017, the City Commission approved the citywide right-of-way improvements contract with Metro Express Inc., as a result of the Invitation for Bid (IFB) process; and

WHEREAS, said contract provided for an initial two (2) year term with an option to renew for two (2) additional one (1) year terms with the last term expiring October 2, 2021; and

WHEREAS, a six (6) month extension to Metro Express, Inc.’s existing contract will be necessary in order to complete various programmed right-of-way projects; and

WHEREAS, Section 2-650 of the Procurement Code authorizes the City Manager to delegate authority to the Chief Procurement Officer to administer and make recommendations on City contracts; and

WHEREAS, the contract with Metro Express, Inc. may be extended under Section 2-829 of the Procurement Code entitled “Approval of Change Orders and Contract Modifications”;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing “Whereas” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.


SECTION 2. That the City Commission accepts the recommendation of the Chief Procurement Officer to extend Citywide Right-of-Way Improvements Contract with Metro Express, Inc. pursuant to Section 2-829 of the Procurement Code entitled “Approval of Change Orders and Contract Modifications,” and allow for a six (6) month extension until May 3, 2022, for the completion of on-going right-of-way projects.

SECTION 3. That the City Commission does hereby authorize the City Manager to execute an extension of the Contract as may be approved by the City Manager and City Attorney that are necessary to implement the intent of this Resolution.

SECTION 4. That this Resolution shall become effective upon the date of its adoption herein.
