**RESOLUTION NO. 2016-153**

A RESOLUTION REQUIRING THE CUBAN CLASSICAL BALLET RETURN FISCAL YEAR 2014-2015 CULTURAL GRANT FUNDS IN THE AMOUNT OF \$2,500.00, DUE TO NOT PRESENTING A CULTURAL PROGRAM IN FISCAL YEAR 2014-2015, REGARDLESS OF BEING GRANTED AN EXTENSION INTO FY2015-2016.

**WHEREAS**, the Cuban Classical Ballet of Miami, Inc. (hereafter referred to as Grantee) entered into an Agreement and received a check for Fiscal Year 2014-2015 Cultural Grant funds in the amount of \$2,500.00; and

**WHEREAS**, the Grantee did not present a program in Fiscal Year 2014-2015 for which funds were granted and, therefore, did not fulfill in a timely and proper manner its obligations under this Agreement; and

**WHEREAS**, the Grantee sent a request for an extension on October 2, 2015 proposing a program for mid-October, 2015; and

**WHEREAS**, the Cultural Development Board granted the extension through October 31, 2015; and

**WHEREAS**, the Grantee did not provide updates or documentation of meeting the extension; and

**WHEREAS**, the Cultural Development Board now requests that the City facilitate return of FY2014-2015 cultural grant funds from the Cuban Classical Ballet in the amount of \$2,500.00;

**BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**


**SECTION 1.** That the foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution upon the adoption hereof.


**SECTION 2.** The City Commission does hereby require the Cuban Classical Ballet return to the City Fiscal Year 2014-2015 Cultural Grant funds in the amount of \$2,500.00.

**SECTION 3.** That this resolution shall become effective upon the date of its passage and adoption herein.
