ITEM TITLE:

Ordinances on Second Reading. Consideration of six (6) Zoning Code text amendments clarifying/amending requirements for the screening of mechanical equipment requested by the Building and Zoning Department, consisting of the following:

1. **Zoning Code Text Amendment - Article 4, Section 4-201, Table 1, Design regulations, #17, "Rooftop screening".** An Ordinance of the City of Coral Gables amending Zoning Code Article 4, Section 4-201, Table 1, Design regulations, #17, "Rooftop screening", updating screening requirements for mechanical equipment; and providing for severability, repealer, codification, and an effective date.
2. **Zoning Code Text Amendment - Article 5, Section 5-603-H-6, "Specific standards".** An Ordinance of the City of Coral Gables amending Zoning Code Article 5, Section 5-603-H-6, "Specific standards", correcting referenced code section from Division 17 to Division 18; and providing for severability, repealer, codification, and an effective date.
3. **Zoning Code Text Amendment - Article 5, Section 5-603-H-7, "Specific standards".** An Ordinance of the City of Coral Gables amending Zoning Code Article 5, Section 5-603-H-7, "Specific standards", updating screening requirements for mechanical equipment; and providing for severability, repealer, codification, and an effective date.
4. **Zoning Code Text Amendment - Article 5, Section 5-1801-D, "Solar water heaters and equipment".** An Ordinance of the City of Coral Gables amending Zoning Code Article 5, Section 5-1801-D, "Solar water heaters and equipment", updating screening requirements for mechanical equipment; and providing for severability, repealer, codification, and an effective date.
5. **Zoning Code Text Amendment - Article 5, Section 5-1802, "Screening of rooftop equipment".** An Ordinance of the City of Coral Gables amending Zoning Code Article 5, Section 5-1802, "Screening of rooftop equipment", updating screening requirements for mechanical equipment; and providing for severability, repealer, codification, and an effective date.
6. **Zoning Code Text Amendment - Article 5, Section 5-1804, "Air-conditioning units and equipment, and other types of mechanical equipment or apparatus installed on or attached to premises".** An Ordinance of the City of Coral Gables amending Zoning Code Article 5, Section 5-1804, "Air-conditioning units and equipment, and other types of mechanical equipment or apparatus installed on or attached to premises", updating screening requirements for mechanical equipment; and providing for severability, repealer, codification, and an effective date.
