## **RECITALS**

WHEREAS, the Agreement expires on April 27, 2021, and the City and Professional desire to extend the Agreement on a month-to-month basis until a new agreement is awarded and executed ("the extension period"); and

WHEREAS, the Professional has agreed to continue providing the Services on a month-to-month basis, under the same price, terms and conditions of the existing Agreement; and

**NOW, THEREFORE**, in consideration of the promises and the mutual covenants contained herein, the City agrees to retain the Professional during the extension period.

- 1. <u>INCORPORATION OF RECITALS.</u> The foregoing recitals are true and correct and are incorporated herein. All terms used herein shall have the meaning ascribed to such terms in the contract, unless defined otherwise herein.
- 2. AGREEMENT PERIOD. The City and Professional hereby acknowledge that the extension period shall commence on April 28, 2021 and continue thereafter on a month-to-month basis, at the same price, terms, and conditions of the existing Agreement, unless terminated earlier pursuant to the terms of the Agreement.

All other terms and provisions of the Agreement are hereby confirmed and shall remain in full force and effect, except as modified herein.
