RESOLUTION NO. 2020-82

A RESOLUTION OF THE CITY COMMISSION ACCEPTING A GRANT FOR FINANCIAL ASSISTANCE IN THE AMOUNT OF \$100,000 FROM THE STATE OF FLORIDA DEPARTMENT OF ENVIRONMENTAL PROTECTION (FDEP) FOR STORMWATER IMPROVEMENTS AND AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH FDEP FOR SAID FINANCIAL ASSISTANCE UNDER FDEP AGREEMENT NO. LPA0009; AND AUTHORIZING AN AMENDMENT TO THE FISCAL YEAR 2019-2020 ANNUAL BUDGET TO RECOGNIZE THE GRANT FUNDS AS REVENUE AND TO APPROPRIATE SUCH FUNDS TO COVER THE COST OF THE GRANT EXPENDITURES.

WHEREAS, upon evaluating the City’s stormwater system’s components, it was determined the area of Sunrise Harbour needs improvement; and

WHEREAS, a majority of the French drains have been compromised due to root intrusion and are beyond repairs; and

WHEREAS, many of the existing structures functioning as catch basin have been found to be inadequate; and

WHEREAS, this grant will allow the City to design and construct exfiltration trenches, catch basins, and manholes at the most critical locations within the community; and

WHEREAS, the State of Florida Department of Environmental Protection agreed to provide financial assistance in the amount of \$100,000.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing “Whereas” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the City Manager execute the agreement with FDEP for financial assistance in the amount of \$100,000.

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.
