SUPERVISOR'S REPORT

a. General Updates

The supervisor's report was initiated by AAC Supervisor Norma Gavarrete, who discussed the AAC's past events for the month of December and forthcoming programs, such as field trips.

AAC Supervisor Norma also mentioned that she had reached the one-year mark as the Supervisor at the AAC and desired to hear the board's perspective on the positive and negative aspects. Moore Park, and William & Leona Cooper Park. He also continued to finalize Phillips Park contract updates and continued forthcoming initiatives for the Rotary Centennial Park.

Board member James "Jim" Berlin then inquired if the AAC will be attending the Farmer's Market to advertise the center, AAC Supervisor Norma Gavarrete responded that the AAC has been scheduled to attend on March 1st.
