RE: Certificate of Appropriateness: Letter of Intent

Remodeling and Addition

Property: 4600 Santa Maria St.

Coral Gables, FL 33146

Dear Chair and Members:

On behalf of Michael Herman and Paulie Hankin, the owners of the property referenced above, I respectfully submit this letter of intent for the approval of a Certificate of Appropriateness.

The existing 2-story, 4,445 SF house sits on a 10,000 SF site. The proposed work includes exterior restoration, replacement of all exterior doors and windows with new impact systems (high-profile muntins), partial interior demolition and full remodel. The restoration of the interior of the existing house includes new mechanical, plumbing and electrical systems, structural repairs and refinishing of all exterior and interior areas. New work includes replacement of the rear 1-story terrace with a new double-height great room (reduction of 33 AC SF), and the conversion of the open-air breezeway from the garage to the house to an AC enclosure (new 30 AC SF). Site work includes driveway remodeling (reduction of paved area), new site walls and gates, new septic system, new stand-alone gazebo, pool & landscape upgrades.

The proposed design and site improvements have been shared with the immediate neighbors and letters of support have been signed by 7 neighbors, attached herewith.

The design intent is to restore original details as much as feasible and maintain the current footprint and 2-story scale of the home. To achieve this, we are requesting two variances.

- 1. Pool setback: The proposed new pool will be centered with the house and located within the rear terrace and replace the existing small pool located on the NW corner of the rear terrace. Due to the lack of space at the rear yard we are proposing the pool setback at 2'-6" from the rear property line facing the Riviera Country Clubs Golf Course vs. the required 5'-0". Note a 6' wide FPL easement maintained by the homeowner runs adjacent to the rear property effectively increasing the setback to 8'-6" from the adjoining golf course.
- 2. Gazebo setbacks: The proposed open-air gazebo will provide a roofed outdoor entertainment area where none exist now. The gazebo proposed location sits away from the main house and tucks in adjacent to the golf course property thereby not infringing on any neighbors' sightlines. Due to the lack of space at the rear yard we are proposing the gazebo side setback at 1'-6" from the south side (adjacent

to the golf course cart path access easement of 25 feet, this easement creates a 25 foot buffer to the south neighbor) and 1'-6" from the west rear property line facing the golf course vs. the required 10'-0". Note a 6' wide FPL easement maintained by the homeowner runs adjacent to the rear property effectively increasing the setback to 7'-6" from the adjoining golf course.
