**RESOLUTION NO. 2009-190**

A RESOLUTION AUTHORIZING THE CITY MANAGER TO AWARD A CONTRACT FOR THE CORAL GABLES COUNTRY CLUB ENVIRONMENTAL REMEDIATION PROJECT TO CHEROKEE ENTERPRISES, INC. (CEI) PURSUANT TO SECTION 2-828 OF THE PROCUREMENT CODE AND REQUEST FOR PROPOSALS (RFP) 2009.06.04 IN THE AMOUNT OF \$228,203.00 (TWO HUNDRED TWENTY EIGHT THOUSAND TWO HUNDRED THREE DOLLARS).

**WHEREAS**, on June 5, 2009 the Procurement Division of Finance formally advertised, issued and distributed the Coral Gables Country Club Environmental Remediation Request for Proposals (RFP) 2009.06.04; and

**WHEREAS**, on June 9, 2009 a non-mandatory pre-proposal conference was held and thirteen (13) prospective proposers attended; and

**WHEREAS**, on June 18, 2009 four (4) responses to the RFP were received, and of those that responded one (1) proposal was accepted, submitted by Cherokee Enterprises, Inc. (CEI); one proposal (1) was rejected for being nonresponsive, submitted by CRB Geological & Environmental Services, Inc.; and two (2) no bids were submitted by WRS Compass and REP Associates; and

**WHEREAS**, on June 19, a Selection Committee reviewed the proposal submitted by Cherokee Enterprises, Inc. (CEI) and is recommending that this firm be awarded a contract to perform the environmental remediation project at the Coral Gables Country Club; and

**WHEREAS**, the City Commission does hereby authorize the City Manager to execute a contract with Cherokee Enterprises, Inc. (CEI) for the Coral Gables Country Club Environmental Remediation project and to include an amendment to the contract under Section 2-768 of the Procurement Code to provide for the overlay of the balance of the parking lot of the Club not included in the remediation project. Overlaying the entire parking lot upon completion of the remediation project, will provide a much needed restoration of the asphalt surface;

**NOW, THEREFORE, BE IT ORDAINED BY THE COMMISSION OF THE CITY OF CORAL GABLES, FLORIDA:**

**SECTION 1.** The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**SECTION 2.** That the City Commission does hereby authorize the City Manager to execute a contract with Cherokee Enterprises, Inc. (CEI) for the Coral Gables Country Club Environmental Remediation project and to include an amendment to the contract under Section 2-768 of the Procurement Code providing for the overlay of the balance of the parking lot of the Club not included in the remediation project; further stating that overlaying the entire parking lot upon completion of the remediation project, will provide a much needed restoration of the asphalt surface

**SECTION 3.** That this Resolution shall become effective immediately upon passage and adoption herein.
