**RESOLUTION NO. 2010-242**

RESOLUTION AUTHORIZING THE EXECUTION OF A TEMPORARY CONSTRUCTION EASEMENT FROM THE CITY OF CORAL GABLES TO THE FLORIDA DEPARTMENT OF TRANSPORTATION (FDOT) FOR THE PURPOSE OF EXPANDING AN EXISTING CURB RAMP ON TO CITY PROPERTY (4133 LEJEUNE ROAD) LOCATED AT THE NORTHEAST CORNER OF THE INTERSECTION OF ALTARA AVENUE AND LEJEUNE ROAD IN ORDER TO COMPLY WITH THE AMERICANS WITH DISABILITIES ACT.

**WHEREAS**, the Florida Department of Transportation (FDOT) has prepared plans for implementation of Americans Disabilities Act (ADA) improvements within the LeJeune Road right-of-way in the City of Coral Gables; and

**WHEREAS**, a defect in the existing sidewalk ramp at the northeast corner of the intersection of Altara Avenue and LeJeune Road needs to be corrected in order to comply with the ADA; and

**WHEREAS**, in order to accomplish the correction to the ramp, it will be necessary to encroach on to City owned property at 4133 LeJeune Road, the Trolley Depot; and

**WHEREAS**, the ramp modification will therefore require the execution of temporary construction easement from the City to FDOT; and

**WHEREAS**, said temporary construction easement shall remain in effect for a period of 33 months, after receipt of the executed easement by FDOT;

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**

**SECTION 1.** The forgoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**SECTION 2.** That the City Commission does hereby direct the City Manager to authorize the execution of a temporary construction easement from the City of Coral Gables to the Florida Department of Transportation for the expansion of an existing curb ramp on City property at 4133 LeJeune Road located at the northeast corner of the intersection of Altara Avenue and LeJeune Road for the purpose of complying with the Americans with Disabilities Act is hereby approved.

**SECTION 3.** This Resolution shall become effective upon the date of its passage and adoption herein.
