**RESOLUTION NO. 2016-82**

**A RESOLUTION ACCEPTING THE RECOMMENDATION OF THE CHIEF PROCUREMENT OFFICER TO EXTEND THE CONTRACT WITH WITT O'BRIEN'S, LLC, FORMERLY KNOWN AS O'BRIEN'S RESPONSE MANAGEMENT, INC., PURSUANT TO SECTION 2-829 OF THE PROCUREMENT CODE ENTITLED "APPROVAL OF CHANGE ORDERS AND CONTRACT MODIFICATION", TO PROVIDE EMERGENCY MANAGEMENT SERVICES, UNTIL JUNE 30, 2016 OR UNTIL SUCH TIME AS A NEW CONTRACT IS EXECUTED.**

**WHEREAS**, on February 23, 2010, the City Commission approved a piggyback agreement with Witt O'Brien's LLC formally known as O'Brien's Response Management, Inc., utilizing a Cooper City, Florida contract that expires March 28, 2016; and

**WHEREAS**, Witt O'Brien's LLC has provided a contract to be utilized with the City of Pompano Beach, Florida Request for Proposal E67-14 titled, Disaster Recover Management Services; and

**WHEREAS**, to allow time to complete a new piggyback agreement, a recommendation of the Chief Procurement Officer to extend the current contract to June 30, 2016, or until such time as a new agreement is executed; and

**WHEREAS**, Section 2-829 of the Procurement Code entitled "Approval of Change Orders and Contract Modifications," authorizes the current contract be extended by the City Commission;

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**

**SECTION 1.** The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**SECTION 2.** That the City Commission accepts the recommendation of the Chief Procurement Officer to extend the current contract to provide emergency management services, until June 30, 2016, or until such time as a new agreement is executed pursuant to Section 2-829 of the Procurement Code entitled "Approval of Change Orders and Contract Modifications," subject to final approval and execution of a contract by City staff.

**SECTION 3.** That this Resolution shall become effective upon the date of its passage and adoption herein.


