**RESOLUTION ACCEPTING THE
RECOMMENDATION OF THE CHIEF
PROCUREMENT OFFICER TO APPROVE A
CONTRACT WITH AECOM TECHNICAL
SERVICES, INC., AS THE DESIGN CONSULTANT
FOR THE RENOVATION OF THE FRED B.
HARTNETT/PONCE CIRCLE PARK PURSUANT
TO FLORIDA STATUTE 287.055, KNOWN AS THE
“CONSULTANTS COMPETITIVE NEGOTIATION
ACT” AND REQUEST FOR QUALIFICATIONS
(RFQ) 2013.10.15**

WHEREAS, on January 28, 2014, the City Commission authorized negotiations with AECOM Technical Services, Inc., an architectural and engineering consulting firm selected as result of an RFQ process, to determine the terms and conditions for consulting services necessary for the renovation of the Fred B. Hartnett/Ponce Circle Park ; and

WHEREAS, the purpose of this contract is to hire a qualified architectural and engineering consulting firm to design and develop plans, specifications, cost estimates and to provide construction administration for the successful completion of the Fred B. Hartnett/Ponce Circle Park renovation project; and

WHEREAS, the Procurement Division of Finance and the Public Works Department have completed their negotiations with AECOM Technical Services, Inc., of Coral Gables, Florida, resulting in the attached contract; and

WHEREAS, the Chief Procurement Officer in consultation with the Public Works Director recommends that a contract with AECOM Technical Services, Inc., be approved; and

WHEREAS, Section 2-650 of the Procurement Code authorizes the City Manager to delegate authority to the Chief Procurement Officer to administer and make recommendations on City contracts.

**NOW THEREFORE BE IT RESOLVED BY THE COMMISSION OF
THE CITY OF CORAL GABLES:**

Section 1. The foregoing “Whereas” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

Section 2. That the City Commission accepts the recommendation of the Chief Procurement Officer to approve a contract with AECOM Technical Services, Inc., as the design consultant for the renovation of the Fred B. Hartnett/Ponce Circle Park pursuant to Florida Statute 287.055, known as the “Consultants Competitive Negotiation Act” and Request for Qualifications (RFQ) 2013.10.15.

Section 3. That all Resolutions or parts of Resolutions inconsistent with, or in conflict herewith, shall be and are hereby repealed insofar as there is conflict or inconsistency.

Section 4. That this Resolution shall become effective upon the date of its adoption herein.
