On behalf of the City of Coral Gables, we are pleased to submit this application to the Florida Division of Cultural Affairs.

On December 11, 2007 the Coral Gables City Commission put into effect the City of Coral Gables Art in Public Places Ordinance No. 2007-37, including "The City of Coral Gables Art in Public Places Program: Funding, Goals, and Implementation Guidelines" draft. As specified in Section 3 of Ordinance 2007-37, until accepted and adopted by the City Commission, provisions of the Ordinance, including the collection of funds and procurement of new public art, are on hold.

The proposed project includes the hiring of a public art master plan consultant to complete the City's public art master plan and announce it with the first of what we hope to be many public art projects. In support of this project, the City has committed \$25,000 as a cash match toward consultant fees and production of an artist designed series of seasonal banners drawing attention to our cultural arts organizations and venues throughout the City.

The City is excited about putting our Art in Public Places program in effect and continuing to enrich the quality of life for visitors and residents through targeted economic and cultural initiatives.
